

## FIA World Rally Championship - 2026 edition Trading Cards

# Golden Ticket Promotion

## Full Promotion Terms & Conditions

### 1. Organizer

The promotion is organized by SportZoo.

### 2. Promotion Period

The promotion starts on the official release date of the 2026 FIA World Rally Championship trading card collection and remains valid till 1st February 2027.

Any Golden Ticket registered after this deadline becomes invalid, and the holder loses all rights to claim any prize.

If a winner cannot be contacted by e-mail, fails to respond within 14 days, fails to provide required information, or fails to complete any required documentation within the timeframe specified by the Organizer, the prize may be forfeited without compensation and an alternative winner may be selected at the Organizer's discretion.

### 3. How to Participate

Selected retail products from the 2026 FIA World Rally Championship trading card collection may contain randomly inserted "Golden Ticket" cards.

To participate, the holder must:

- Find a valid Golden Ticket card.
- Register the ticket through the official registration website: [www.sportzoo.net/wrc2026](http://www.sportzoo.net/wrc2026)
- Provide all required information truthfully and completely.

Only successfully registered tickets are eligible for prizes.

### 4. Prize Types

The promotion includes the following prizes:

1× Rally Co-Drive Experience

3× Behind the Scenes Visit (for 2 persons each)

10× Official WRC (FIA World Rally Championship) Merchandise Packs

Prizes are allocated according to the specific Golden Ticket found.

### 5. Prize Conditions - Rally Co-Drive Experience

The Rally Co-Drive Experience is subject to strict safety and operational requirements.



The winner:

- must be at least 18 years old,
- must be physically and medically fit to participate,
- must comply with all safety instructions,
- may be required to sign waivers, declarations, or liability documents.

If the winner does not meet safety, medical, operational, age, size, weight, equipment, or behavioral requirements, the Organizer and/or event officials reserve the right to refuse or terminate the winner's participation in the Rally Co-Drive Experience. In such case, the winner shall not be entitled to any compensation, reimbursement, replacement prize, or alternative activity.

Final participation is subject to on-site assessment and approval by event safety officials.

The specific WRC driver, vehicle, team, and session assigned to the Rally Co-Drive Experience shall be determined solely by the Organizer, and/or event officials. The winner shall not have the right to choose, request, or change the assigned driver, vehicle, team, or session.

The experience may involve high speed, sudden impacts, loud noise, and physically demanding conditions. Participation is entirely at the winner's own risk.

No guarantee is given that the winner will ultimately be able to participate in the experience, including after selection, if safety, medical, operational, or external conditions prevent participation. The decision of the Organizer, medical personnel, or event safety officials regarding fitness to participate shall be final and binding.

The Organizer's decision regarding eligibility, selection, and fraud assessment is final, binding, and not subject to appeal.

The Organizer reserve the right to modify the event, date, location, or format of the experience if required due to operational, safety, or scheduling reasons.

## **6. Travel and Personal Expenses**

Unless explicitly confirmed otherwise in writing by the Organizer, all costs related to prize participation are the sole responsibility of the winner and/or guest, including but not limited to:

- flights
- accommodation
- visas
- passports
- insurance
- local transport
- meals
- personal expenses
- taxes
- customs fees
- and any other related costs

Winners and guests are solely responsible for obtaining and maintaining valid passports, visas, travel authorizations, vaccinations, and any other documentation required for participation.

## 7. Event Availability and Changes

All experiences are subject to:

- FIA World Rally Championship calendar availability
- operational restrictions
- weather conditions
- safety requirements
- local regulations
- and third-party availability

The specific FIA World Rally Championship event, date, location, session, and all related arrangements for both the Rally Co-Drive Experience and the Behind the Scenes Visit shall be determined solely by the Organizer based on operational availability, safety considerations, accreditation requirements, and the official WRC calendar.

Winners shall not have the right to choose, request, or change the assigned event, driver, team, vehicle, session, date, or location. The winner's preferences may be considered, but are not binding and do not create any entitlement.

The Organizer and reserve the right to assign, substitute, or change the selected event at any time due to scheduling, safety, or operational requirements.

## 8. Responsibility for safety

Any guest accompanying a winner shall be subject to the same safety, security, accreditation, behavioral, and operational requirements.

The Organizer accept no responsibility for any personal injury, property damage, or indirect loss arising from participation in the prize activities, except where such liability cannot be excluded under applicable law.

Winners shall be fully responsible for their guests and any actions or omissions of their guests during the prize experience.

The Organizer, and event officials reserve the right to remove, disqualify, or exclude any winner or guest whose behavior is deemed unsafe, disruptive, abusive, inappropriate, or inconsistent with event rules.

## 9. Transfer of Winner Information

By registering a Golden Ticket, participants consent that their personal data may be shared with FIA World Rally Championship (WRC) and authorized third-party partners strictly for prize fulfillment, logistics, and legal compliance.

Only original Golden Tickets issued by the Organizer and successfully validated by the Organizer shall be considered valid.

## 10. Fraud and Invalid Claims

The Organizer reserves the right to reject any claim involving:

- damaged or unreadable tickets
- duplicated registrations
- fraudulent claims
- manipulated tickets
- or any violation of these Terms & Conditions

The Organizer's decision regarding fraud assessment is final and binding.

The Organizer reserves the right to disqualify any winner at any time if eligibility requirements are found not to have been met or if a violation is discovered after selection.

## 11. Non-Transferability

Prizes are:

- non-transferable
- non-exchangeable for cash
- and may not be resold

The Organizer is under no obligation to reschedule participation if a winner or guest becomes unable to attend due to personal circumstances. There shall be no entitlement to rescheduling, substitution, or compensation if a winner or guest is unable to attend for any reason, including illness, travel disruption, or personal circumstances.

Failure to attend the scheduled time, location, or required check-in for any part of the prize experience shall result in forfeiture of that portion of the prize without compensation.

## 12. Limitation of Liability

To the maximum extent permitted by law, the Organizer, SportZoo affiliated partners and event operators shall not be liable for any:

- cancellations
- injuries
- losses
- damages
- delays
- travel disruptions
- or inability to redeem the prize due to circumstances outside their reasonable control, including but not limited to natural disasters, extreme weather, government restrictions, public health emergencies, labor disputes, security concerns, acts of terrorism, or cancellation of sporting events.

## 13. Event Cancellation or Substitution

In the event that a prize experience cannot be delivered due to cancellation, postponement, or circumstances beyond the Organizer's control, the Organizer reserves the right to substitute the prize with an alternative of equivalent nature or value.

#### 14. Final Decisions

All decisions made by the Organizer regarding promotion administration, eligibility, selection, and prize fulfillment are final and binding.

These Terms & Conditions shall be governed by and construed in accordance with the laws of the Slovak Republic. Any disputes arising out of or in connection with this promotion shall be subject to the exclusive jurisdiction of the courts of the Slovak Republic, unless mandatory consumer protection laws provide otherwise.
